Vice Commodore: 13 people attended the April 30th work party. Stairs were repaired and painted. Annual fire extinguisher recharge and smoke alarm inspection is complete. Stove unit inspection (2 times per year) was done.

Agawam Rear Commodore: Thanks to everyone working on the docks. Boats in the basin must be fully operational and all motors must be up. Work party is scheduled for 5/7 but due to water level a decision to postpone will be made by Friday 5/5 at 1 PM. We plan to clean and build an organized system under the deck. Thanks to Jim T the crash boat is ready to go. On Saturday, May 6 we can put mooring balls out and fix permanent docks. Chester Rear Commodore: One sublet available by Joe Carenzo. 3 outside slips are available. Road is fixed and trenches are backfilled thanks to Benton. Loam was delivered this weekend along with grass

and seed. Work party scheduled for 5/6 for decking plates and the bathroom cleaning. There will be no reconfiguring of docks unless we find a safety issue. The electrician will be done by 5/13. Thanks to the electrician for all the hard work.

By Law committee: We need to remove the 10% restriction and vote on the increase. There is a recommendation to change the initiation fee to \$200.00, to consider family membership, and to have 20% of fees stay in the basin. Final by law changes have to be in by 5/16/17

Quartermaster: QM ordered flags for officers and US flags and delivery is 4 weeks out.

Unfinished Business: We need a decision on the new office/wall downstairs that reduces the available space in the basement. The membership voted 12 in favor and 14 against so the wall will be removed.
